### Dear Rafik Khachatryan!

The Non-Profit Organisation "Eurasian Centre for Accreditation and Quality Assurance in Higher Education and Health Care" (ECAQA) hereby informs you of the decision of the Accreditation Council dated 11 July 2025, Minutes No. 6:

- To accredit the Production Cooperative "Progress-University" for a period of five
   (5) years, from 11.07.2025 to 10.07.2030;
- To accredit the Bachelor's and Master's (Integrated and continuous) Educational Programme in the speciality "091201.00.6 and 7091201.00.7 – General Medicine" (Armenian and English mediums of instruction) of the Production Cooperative "Progress-University" for a period of five (5) years, from 11.07.2025 to 10.07.2030.

Post-accreditation monitoring, in accordance with the accreditation process, will be carried out by ECAQA over a five-year period and will include the submission of an annual report on the implementation of the recommendations made by the External Expert Commission (EEC) to improve the institutional activities of Progress-University and the educational programme.

An official letter regarding the international accreditation of the above-mentioned institution and educational programme will be sent to the Ministry of Education, Science, Culture and Sports of the Republic of Armenia.

The reports of the external expert commission and the decision of the Accreditation Council will be published in the European Database of External Quality Assurance Results (DEQAR) and the Database of Asia-Pacific Quality Assurance Results (DAQAR). As a full member of the European Association for Quality Assurance in Higher Education (ENQA), ECAQA will officially publish the full version of the external evaluation report in accordance with the requirements and implementation parameters of the Bologna Process.

The reports of the External Expert Commission, the decision of the ECAQA Accreditation Council, and the Certificates of Institutional Accreditation and Programme Accreditation will be published on the ECAQA website in the "Reestr" section: https://www.ecaqa.org/en/reestr-en.

We congratulate the management and staff of the Production Cooperative "Progress-University" on the successful achievement of your accreditation preparation goals. We thank you for your support and the opportunity for productive cooperation in the implementation of international principles and standards for quality assurance in higher education in the Republic of Armenia.

Enclosed with this letter are the Certificates of Institutional and Programme Accreditation (*Annex 1*) and the External Expert Commission Reports on the institutional evaluation of Progress-University and the programme evaluation, including recommendations for improvement.

### Post-accreditation monitoring will include:

- The preparation of a document titled "Action Plan on the Recommendations of the ECAQA External Expert Commission (EEC) for the Period 2026–2030" and submission of the signed and approved original to ECAQA no later than 29 August 2025 (structure of the plan and list of EEC recommendations are provided in Annexes 2 and 3, respectively).
- Submission to ECAQA of an annual report titled "Report on the Implementation of Improvement Activities in Accordance with the Recommendations of the ECAQA External Expert Commission for the year \_\_\_", no later than 20 December of each year, starting from 2026 through 2030 inclusive.

Reports shall be completed in a tabular format, in accordance with the action plan. They must include the date of implementation, details on the execution of corrective measures, and evidence of implementation (reference numbers of documents, etc.). When submitting the report, Progress-University must provide the relevant annex with certified copies of supporting documents. The report must be signed and approved by the Rector of Progress-University or a person duly authorized by the Rector.
